Previous minutes

1. The minutes of 7 March 2023 were agreed.

Business Programme

- 2. The Bureau considered a revised programme of business for the week commencing 13March 2023 and a programme of business for the weeks commencing 20 and 27 March 2023.
- 3. The Bureau agreed to propose to Parliament the suspension of Standing Orders Rule 15.2.1 so that meetings could take place with no public access to public galleries on Wednesday 15 March. Neil Bibby did not support this and reserved his party's position on the motion.
- 4. Neil Bibby and Alexander Burnett reiterated concerns about the rescheduling of opposition business debates which had been due to take place on 22 and 29 March. It was recognised that efforts had been made to ensure an even distribution of opposition business across the Parliamentary year, but Neil Bibby stated that the reasons provided by the Minister for Parliamentary Business for the rescheduling of business were not adequate.
- 5. Alexander Burnett and Neil Bibby reserved their parties' position on the revised business programme.
- 6. The Bureau agreed that Members' Business on Tuesday 21 March would be S6M-06478: Jamie Halcro Johnston: Road Improvements and the Dualling of the A9, on Wednesday 22 March S6M-07482: Jenni Minto: 100 Years of the BBC in Scotland and on Thursday 23 March would be 6M-07686: Pauline McNeill: Supporting Taxi Drivers
- 7. The Bureau also agreed that the Members' Business debates scheduled to take place on 15 and 16 March (Marie Curie's Great Daffodil Appeal and Benefits of Camping) be reversed.
