The Conveners' Group provides an informal forum where Committee Conveners can meet to discuss matters of mutual interest and to facilitate liaison between the Committees, the Parliamentary Bureau and the Scottish Parliamentary Corporate Body.

Under Rule 6A.3.1 of the [Standing Orders](#) the Presiding Officer convenes and chairs meetings of the Conveners Group. The Presiding Officer can delegate their functions to convene and chair the Conveners Group to a Deputy Presiding Officer under Rule 3.1.5.

Remit: The Group handles a range of matters, for example:

- (a) approval of travel by committees or committee members
- (b) approval of meetings of committees outside Edinburgh
- (c) consideration of the biannual programme of committee meetings
- (d) endorsement of funding for civic participation events and external research
- (e) making recommendations to the Bureau on committee business to be scheduled in the Chamber.
