What is an 'urgent question'?

From 4 September 2017, following the report of the Commission on Parliamentary Reform, emergency questions became known as urgent questions. They are a category of Parliamentary Questions which allow Members of the Scottish Parliament (MSPs) to get information and comment on a matter of immediate concern. They can only be lodged on days when the Parliament has a plenary meeting and must be lodged before 10.00 on the day that the MSP is requesting an oral answer.

After it is lodged it is the Presiding Officer (PO) who decides if the question is sufficiently urgent enough to require being put as an urgent question. If the answer is yes then a revised Business Bulletin (BB) is published containing the question and the time it will be taken and the BB is updated on the website. At the allocated time the member may ask their question and one supplementary. At the discretion of the PO any member may ask further supplementary questions.

The answers are given by the relevant Scottish Government Minister or Law Officer or the First Minister.

If the PO does not allow the question to be put the question falls and will not appear in the Business Bulletin and will not be answered unless the member resubmits it as an oral or written question.

What is an Urgent SPCB question?

Urgent SPCB questions became possible from 12 May 2021 as a result of motion S5M-24366 being agreed by the Parliament on 17 March 2021.

This change was recommended by the Standards, Procedures and Public Appointments Committee in its 8th Report 2021, Standing Order Rule changes – Urgent questions to the Scottish Parliamentary Corporate Body, for occasions when urgent questions need to be raised with the SPCB.

Urgent SPCB questions are defined in the Standing Orders, Rule [13.9A](#). An urgent question under this Rule may be put to and answered by any member of the Parliamentary corporation.
